Know all by these presents, that I do here appoint each of Roy E. Halyama, Matthew W. Rucker, Patrick “Kip” Huffman, Kirtan Parikh, and Zayne R. Tweed, each acting singly, and with full power of substitution, re-substitution, and delegation, the undersigned’s true and lawful attorney-in-fact (each of such persons and their substitutes and delegees being referred to herein as the “*Attorney-in-Fact*”), with full power to act for the undersigned and in the undersigned’s name, place and stead, in the undersigned’s capacity as an officer, director, or stockholder of Burke & Herbert Financial Services Corp. (the “*Company*”), to:

1. 
